Please provide the complete minutes of the meeting of the transport committee where the snapper on trains business case / memo / paper was discussed and approved / endorsed.

Please provide the complete minutes of the meeting of the transport committee where the pilot of the snapper on trains was discussed and approval for rollout was given.

Based on responses to previous OIA requests it is absolutely clear that there are serious issues with the governance and oversight of the snapper on trains service.”
