Request for information 2024-030

I refer to your request for information dated 28 February 2024, which was received by Greater Wellington Regional Council (Greater Wellington) on 28 February 2024. You have requested the following:

"Location of Greater Wellington's CCTV cameras (including those for the Metlink transport network, corporate buildings, and regional and forest parks), including GPS-enabled format (where available)

- Type of camera
- Hours of operation
- Orientation / field of view
- Technical capabilities (e.g., pan, title, zoom, low light conditions, and infrared) and resolution
- Process and contact point for requesting access to each CCTV system."

Greater Wellington's response follows:

Please refer to Attachment 1 for details on type of camera, orientation/field of view of these cameras, hours of operation, orientation/field of view and technical specifications. There are two tabs to the spreadsheet, one for Metlink and one for all other cameras. Attachment 2 and Attachment 3 show more details information on the equipment layouts through the bus and rail networks.

In relation to the PTZ cameras that are used on the transport network, these are the only cameras that have zoom capability. As our stations and carparks are lit throughout all hours of the day, low light and infrared capability is not necessary. Please refer to **Attachment 4** for more specifications provided by the manufacturer.

Please refer to **Attachment 5** for details of cameras at our Masterton office. Details for our Upper Hutt office are included in Attachment 1.

You will see there are two cameras outside the building in the back lane – although that lane is not accessible by the public. The camera in the main front entry lobby also has a view of the footpath outside on Cuba St (through the glass auto doors), but the view of the public passing by has been obscured on the footage captured for privacy reasons.

These cameras are all in operation 24/7.

Requests for access to camera surveillance video footage, images are managed under the Local Government Official Information and Meetings Act 1987 or the Privacy Act 2020.
