- 1 ACCEPTANCE
- 1.1 **The Competition:** This Competition is run by Greater Wellington in accordance with these competition rules.
- 1.2 **Deemed acceptance**: When a person submits an Entry, they are deemed to have accepted these Competition Rules.
- 1.3 **Minors:** Persons under the age of 18 are not able to Participate in the Competition.
- 2 ENTRY PROCESS
- 2.1 **The Entry:** On or before the Entry Deadline, a Participant must comment on the Competition Post responding to the question posed in the Competition Post (an Entry).
- 2.2 **One entry only:** A Participant may only complete one Entry and may only win one Prize.
