

## Request for information 2025-215

I refer to your request for information dated 9 July 2025, which was received by Greater Wellington Regional Council (Greater Wellington) on 9 July 2025. You have requested the following:

"This is a request for official information under the Local Government Official Information and Meetings Act 1987 in relation to the new rainbow design on Manners Street bus connection (stop 5515) in Wellington.

We request the following information:

- The total amount budgeted for this project.
- A detailed breakdown of the construction costs related to the implementation of this design on Manners Street. Including (but not limited to) the costs of supplies, labour, designing and any other related expenses.
- Any other further costs related to this project that fall outside the previously stated categories, but are relevant to the design and construction process. I would appreciate it if these could be considered and included in your response.

Please indicate whether any figures provided are inclusive or exclusive of GST. Where possible, data presented in an Excel format is preferable."

## **Greater Wellington's response follows:**

Please see **attachment 1** which contains the invoice for the works to install the rainbow design on the Manners Street bus stop 5515.

We have redacted the bank account number of the installer as out of scope of the request.

The design process was undertaken in house, with amendments for printing undertaken by a signage company. The invoice breaks down all costs related to the installation of the rainbow decal.

The pride bus shelter decal represents Metlink's commitment to championing diversity and inclusivity. We strive for a public transport network where everyone feels safe using our services, including when waiting for a bus to arrive. We know 89% of passengers feel safe waiting at our stops, stations, and wharfs.

For such a small investment in our community, the social impact outweighed the cost of installation with the pride bus stop coverage reaching:

- 131,000 people on social media, with 207,920 impressions, 3,652 reactions, 388 comments and 105 shares,
- more than 300 website visitors,
- and the hundreds of thousands of tourists, residents, and passengers moving through the Golden Mile each day.

If you have any concerns with the decision(s) referred to in this letter, you have the right to request an investigation and review by the Ombudsman under section 27(3) of the Local Government Official Information and Meetings Act 1987.

Please note that it is our policy to proactively release our responses to official information requests where appropriate. Our response to your request will be published shortly on Greater Wellington's website with your personal information removed.
